You earn the standard 20% on clients you personally refer, plus a 10% override on every qualifying client referred by someone on your team.

THE SIMPLE AGREEMENT

- 1 Submit personal referrals before the client engages Wake Up. New referrals, or people not already in an active Wake Up conversation, qualify. If a referral is duplicated, the earliest verified submission controls.
- 2 Wake Up will pay you 20% of program and service fees actually collected from a qualifying client you directly refer.
- 3 You may recruit Affiliates to join your team under standard Affiliate Circle terms. On program and service fees collected from a client referred by a member of your team, Wake Up pays 10% to the referring Affiliate and a 10% override to you.
- 4 Referral fees and overrides are paid within 30 days after the client's payment clears. Refunds, credits, chargebacks, taxes, and pass-through expenses are excluded or adjusted.
- 5 You make introductions and support your team; Wake Up handles the conversation, proposal, pricing, contract, and delivery for every client. You may not bind Wake Up or promise terms on its behalf, for yourself or your team.
- 6 Represent Wake Up honestly and respectfully, and require the same of every Affiliate you recruit. No spam, misleading claims, or sharing a person's information unless they reasonably expect to hear from us.
- 7 You and your recruited Affiliates are independent affiliates, not employees or agents. Each is responsible for their own taxes, and a W-9 may be required before payment.
- 8 Either side may end this relationship at any time. Qualifying referrals and overrides accepted before termination remain eligible for the stated fee.
